

**2021 CALENDAR, SIXTH JUDICIAL DISTRICT, STATE OF UTAH**

The intent of this calendar is to notify counsel, staff and citizens of regular court days in the six counties of the district. A "Law & Motion" day means a day when the court is available to handle short, routine matters in civil, criminal, domestic and probate cases such as initial appearance, arraignments, default hearings, sentencing and reviews. **Note:** The procedures for handling motions are found in Rule 7 URCP and Rule 12 URCrP. In most instances, courtroom facilities are shared by the District and Juvenile courts.

If you have questions, please call. The reverse side contains a listing of telephone numbers you might need. **This is a tentative schedule for 2021.** At times the schedule must be changed, such as when adjusting for a long trial or for judicial training. Our goal is to make your court appearance as convenient and efficient as possible. In most instances, court appearances will be handled remotely, and arrangements must be made if parties want to appear in-person.
